The Gig Harbor Farmers Market Association in no way guarantees the marketability or fitness of the vendors' goods, nor does the Gig Harbor Farmers Market Association guarantee the success of the vendor's efforts. Members will be accepted on the basis of residency within the Greater Peninsula boundaries, market balance and seniority.

All vendors who wish to erect canopies (including umbrellas) on the farmers market site during a normal period of market operations, including the set up and break down period, are required to have their canopies sufficiently and safely anchored (25 lbs per leg) to the ground from the time there canopy is put up to the time it is taken down. Any vendor who fails to properly anchor his or her canopy will not be allowed to sell at the farmers market on that market day, unless that vendor chooses to take down and stow their canopy and sell without it.

- 3. New Craft Vendor \$10 fee for jury of craft before accepted in the GHFM
- 4. New Farm Vendor \$30 Farm Inspection fee for new farmers before accepted in the GHFM
- 8. Booth Space \$25.00 per day per space (12' x 12') one UBI # (Business) per booth at PG
- 9. Market Fee 5% of total market gross sales at PG Categories to include: Farmers, Crafters, Processors, Resellers and Food Vendors
- 10. Returned check \$33.00
